In 2017, EVAWI had 4 federal grants that provide funding for EVAWI to provide technical assistance and support through on line and web based training materials and resources. The Online Training Institute (OLTI) offers learning tools to aid in the proper investigation and prosecution of sexual offenders. In the past 10 years, nearly 25,000 people have participated in EVAWI's Online Training Institute, growing with about 4,500 new registrations in 2017 alone. In 2017, these users participated in more than 8,000 modules, racking up more than 1.6 million hours of training. Additionally, EVAWI provides numerous web based resources and tools such as a library, archived webinars, FAQ's and recommendations for best practice. In 2017, EVAWI's website had nearly 4.6 million page views and visitors

EVAWI is America's leading Nonprofit Organization dedicated to improving criminal justice responses to sexual assault. EVAWI holds conferences supported by registration fees, to educate multi-disciplinary teams of law enforcement, prosecutors, health care professionals, and victim advocates. Our 2017 international conference had over 2,000 attendees, representing 39,800 training hours. Participants came from all fifty states, 4 US territories, and 12 countries. In 2017, EVAWI also held three regional conferences in Cincinnati, St. Louis and New York where we provided 6,315 hours of training to 262 attendees.

Start by Believing (SBB) is a global campaign, promoted and supported with non-grant funds, designed to transform the way society responds to sexual assault because negative responses worsen the trauma and create an environment where perpetrators face no consequences.

The SBB is dedicated to changing the way society responds to victims of sexual assault to make it easier and safer to seek help. EVAWI helped numerous communities launch their own start by believing campaigns.
