**EVAWI is America's leading Nonprofit Organization dedicated to improving criminal justice responses to sexual assault. EVAWI holds conferences supported by registration fees, to educate multi-disciplinary teams of law enforcement, prosecutors, health care professionals, academia and victim advocates. Our 2019 international conference had 2,184 attendees, representing 42,042 training hours. Participants came from 48 states, 5 US territories, and 11 countries.**

We promote victim-centered multi-disciplinary collaboration, which strengthens the response of the criminal justice system, other professionals, allies, and the general public - making communities safer.

In 2019, EVAWI had four federal grants to provide technical assistance and support through on line and web-based training materials and resources. The Online Training Institute (OLTI) offers learning tools to aid in the proper investigation and prosecution of sexual offenders. Since the OLTI was launched in 2007, 32,637 people have participated in EVAWI's Online Training Institute, with 5,045 new registrations in 2019. Users completed 10,969 modules, representing 95,399 hours of training. EVAWI also provides numerous web-based resources and tools such as a library, archived webinars, FAQ's and recommendations for best practice. In 2019, EVAWI's website had nearly 7.4 million page views and visitors downloaded an average of 850 resources per day. EVAWI also continued working in partnership with three subrecipients on two other federal awards, Seek Then Speak/Victim Link and the Sexual Assault Medical Forensic Examiner Training Initiative.

Committee uses comparable data generated by Charity Navigator's Formula for Non-Profit Organizations. Charity Navigator is a well-known research organization that surveys non-profit organizations across the country and creates a standard for the industry. The formula for CEO compensation is based on several factors, including geographic region, size and mission of the organization, as well as annual revenues and performance. EVAWI is considered a mid-to-large sized charity, which is defined as a charity with \$1 million or more in revenues.

When a change in executive compensation is under consideration, the Financial Committee makes a recommendation to the Board of Directors based on the Charity Navigator formula and other factors such as performance. The Board of Directors votes to approve or reject the recommendation. The Minutes for the Board meeting are filed in accordance with EVAWI's bylaws, documenting deliberations and the basis for a decision. Although we had been following these procedures since our CEO and founder first received compensation, Policy No. 27, Executive Compensation was approved by the Board of Directors on February 19, 2020 to ensure the procedures are documented in policy.
